### **IMPLEMENTATION OF NEW SERVICES ONLINE**

#### GO LIVE WITH OUR ADDITIONAL CHANGES

We wish to advise that we will be increasing our online service offering with the automation of new processes from May 2021 to July 2021. Details of the new services planned for implementation on the Taxpayer Online Services (TPOS) are listed below:

1 <sup>st</sup> July 2021	Personal Income Tax Return Filing Corporate Income Tax Return Filing Taxpayer Requests – Income Tax Concessions Capital Gains Tax Return Filing Student Loan Scheme Taxpayer Request - New Dwelling House VAT Refund Taxpayer Request - 1 <sup>st</sup> VAT Refund

#### ADDITIONAL IMPORTANT INFORMATION

1. FRCS will accept manual filing of Personal Income Tax (Commonly referred to as Form S and Form B) and Corporate Income Tax (Commonly referred to as Form C) returns for tax years 2020 and prior until June 2021.

However, effective 1<sup>st</sup> July 2021 all Personal Income Tax and Corporate Income Tax returns must be filed online through Taxpayer Online Services.

2. All employees to note that effective from 1<sup>st</sup> July 2021 after the live roll-out to electronically file Personal Income Tax and Corporate Income Tax return, they will be able to apply for their "Statement of Employment Income" electronically through the Taxpayer Online Service.
3. We will continue to communicate and inform you of our latest update and any changes as we progress in the coming months.
